CBT Challenge Race will be run after the pre-entry draw, prior to the add-on draw on Saturday. Drag every 3 runners. Limited to first 30 paid-in-full entries. Time can count as Christmas Ca\$h Saturday run. You do not have to be entered in Christmas Ca\$h race to enter CBT Challenge Race.

**30 entries will pay 7-places\*, as follows: \$2500, \$2000, \$1500, \$1000, \$700, \$500, \$300.**

\*If less than 30 entries, alternative payout will be posted prior to competition.

5pm--Office open for slot/exhibition payments.

6pm-7pm--20-minute riding slots\*, \$10 each.

10am-11am--Exhibitions\*, \$5 each.

Noon--\$1,000 added open round #1.

7am--Church Service.

7:30am--Office opens.

8:30am--\$1,000 added open round #2. \$500 added bonus round to start 1 hour after the open.

**Bonus round rules.** The top 8 runners from each division (on a 5D scale), each day in the Open will qualify for the bonus round. You must pay the \$120 weekend entry to be eligible for qualification to the bonus round. The bonus round will be a clean slate 4D. Average times will be figured on qualifying time and bonus round time.

Produced by CBT Productions. Vendors will be on-site. Dress code required. Official Photographer is PixelWorx.

**\*Exhibitions & Riding Slots:** Exhibition & riding slot reservations will be taken by telephone Wednesday, December 1st from 4pm-7pm (TX time) by calling 806-488-2144. Phone-in reservations MUST be paid for in the office 1 hour prior to time slot or the exhibition/riding slot will be sold, no exceptions! A riding slot is a 20-minute open arena session with barrels, limited to 12 riders per session (no ponying or leading horses).

All entries close when the first horse runs. A \$10 per horse late fee applies to on-site entries and entries mailed after November 17th. Stalls available for \$18 per night. All stall and RV hookups will be through the Tri-State Fair office upon arrival. No reservations required. Stalls will open Friday at 1pm.
